## **Cannon County Board of Education Sets Meeting Dates and Times for 2025-2026 Term**

WOODBURY – The Cannon County Board of Education voted on August 14, 2025, to set meeting dates and times for the 2025-2026 term of the board. Cannon County Board of Education Policy 1.402 states, “The Board shall ensure adequate public notice of all regular meetings by publishing a complete schedule for the entire school year. This schedule shall be posted in the central office, each school, and on the school system’s website and sent to the president of the local education association.

In the event of a special board meeting, notice shall be provided at least forty-eight (48) hours prior to the meeting and shall be posted in the same locations and in the same manner as regular board meetings. All notices of special board meetings shall state the time, place, and purpose of the meeting.

The only exception permitted is in the case of an emergency, defined for this policy as a sudden, generally unexpected occurrence or set of circumstances demanding immediate action. In such exceptions, notice shall be given to all appropriate parties as is practical.

Notice of all meetings with actionable items on the agenda, with the exception of teacher disciplinary hearings, shall include information on how community members can participate in the public comment portion of the board meeting.”
